1. Complete the Notice of Transfer form, located on the back of your dealer aircraft registration.
2. Collect the civil registration fee from the purchaser, one cent per pound of max gross takeoff weight.
3. Mail the completed transfer form and the civil registration fee to the MDOT aircraft registration address, listed below.
4. Mail only the completed transfer form if the aircraft will no longer be based in Michigan.

Upon receipt of Steps 1-3, a civil registration will be issued to the purchaser.

Mail this completed form to: MDOT – Finance Cashier, P.O. Box 30648, Lansing, Michigan 48909. Also, include a \$25.00 check, non-refundable processing fee, made payable to the **State of Michigan**.
